## Methods and materials for containment and cleaning up

Small spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. #### Precautions for safe handling

# Appropriate engineering controls

: Use only with adequate ventilation.
