SECTION 4: First aid measures

4.1. Description of first aid measures

First-aid measures after inhalation

: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get immediate medical advice/attention.

First-aid measures after skin contact


